

**TEMPORARY CLOSURE OF VARIOUS ROADS

Gloucestershire County Council has made an order under the Road Traffic Regulation Act 1984 (as amended) to temporarily close and restrict part of the roads as detailed in the Schedule below.

The reason for the closures and restrictions is the installation of Gigaclear Rural Fibre.

The roads are expected to be closed and restricted on a rolling programme commencing 18<sup>th</sup> January 2021, where the presence of approved signage will indicate whether the closure and restriction is in force. Further advance warnings of dates/times will be displayed on site prior to the closure and restrictions taking effect. This order can permit the closure and restriction of the roads in any order, or simultaneously as required and it is anticipated all works will be completed by 1<sup>st</sup> June 2021.
