1. **Apologies and Absence-** Received from Cllrs Reynolds and Fryer. District Cllrs Jones & Craig
2. **Declarations of Interest-** None received.
3. **District & County Councillor reports-** Penny was very pleased with the event at Sharpness Community Pool and thanked all involved. Penny went through the SDC corporate delivery plan 2018-2020. The review of car parking charges (not in place) was discussed and how it will affect local business. Also, we are down to 6 wardens in the district not 8. There is a shortage of recycling bins. Lots to discuss at the SDC meeting.
4. **Minutes from the last meeting held 15th May & the APM held 22nd May 2018** were taken as a true account, DB proposed this PM 2nd.
5. **Committee Meetings-** The minutes from the Finance meeting were noted by all. Internal controls were carried out by DB & PM
6. **Matters Pending-** There were no matters pending.

8. **Park Reports-** Were noted by all. Park officer has emailed Rospa with a query and hopes to hear back shortly. NC will send a report to Clerk as no item on agenda to discuss other items.

9. **Planning-**

- A) **Soap box Racing**, Purton. See also Public Participation. Clerk was given authority to comment on this application when it arrives. **All agreed** happy for road closure.
- B) **47 Cromwell close-** Two storey and side extension- **All agreed** to support his.
- C) **2 Canal Bank Purton** - Revised Plans. – **All agreed** to this.

10. **Community Bus-** Council were disappointed with the lack of interest. Only 6 people showed interest and three of those were outside the Parish. After a lengthy discussion NC proposed that due to lack of interest, The PC do not take this further at this moment in time. DB 2nd this. **All agreed**. Clerk was instructed to put a small piece in Church magazine.

11. **Lease /Agreement**

- A) **To agree retrospectively on the half-moon lease-**The lease was agreed by all.
- B) **Wind Turbine-** The agreement for the community grant was agreed by all. NOTE- this is a lease sent to the Wind turbine company, the PC have NOT signed anything or received any money to date

12. **Allotment compost site-** The Clerk has met with Leyhill Officers and they can clear this site, but it will take four days of 12 men, maybe more, and then skips will be needed. Clerk has contacted local farmer, but he cannot do it due to not having a trailer. The Clerk has asked another person and is still waiting to hear back. The Clerk was instructed to contact the last person and see if they have a price, if cheaper then they will be used. All Agreed for DB & Clerk to deal with this.

13. **Clerks Report-** Scribe- The Clerk has spent approx.25 hours setting up the new package. It is finally up and running, fingers crossed. It will take a while to get used to it. The Clerk also thank the Council for swapping the dates for the meeting.

14. **Cllr's Report- PM** gave a report on the Chartered meeting he attended. **NC** said that Purton Green is looking much better now regular mowing has taken place. There is obscene graffiti over the half moon, more NO DOG signs are needed by the park entrance, and finally why does the gate not lock to the park? Clerk said we are STILL waiting for the red container to be removed.
DB- When will the red container be removed, Chairman is working on this, swimming pool open evening was very enjoyable & The recumbent bike is making a noise. Clerk to report this.
